It's time to plan for next year already! Naperville School District 203 will perform its Online Annual Update for the 2021-2022 school year for all returning students entering grades preschool or 1st -12th grade.

Beginning today, May 3, 2021, all families will be required to update their student's information through their Campus Parent Account. The Online Annual Update for returning families must be completed by May 31, 2021. We will not be able to assign your student to a teacher or schedule for the 2021-2022 school year until the Online Annual Update is completed. If you do not complete your update by the deadline, you will be required to complete the Online Annual Update **AND** provide proof of residency in order for your student(s) to attend a Naperville 203 school for the 2021-2022 school year.

The following information will assist you in completing each of your student's Annual Update for the 2021-2022 school year:

• To access the Online Annual Update, you will need your Campus Parent username and password. If you do not have a Campus Parent Account, contact *Parent Support* at parentsupport@naperville203.org.

If your Online Annual Update reflects a change of address, proof of residency at your new address must be provided. If there is a change in the family structure *i.e. divorce*, a Parenting/Custody Agreement must be provided for these changes/updates to take effect. Documents may be uploaded for review while completing your Online Update, emailed to Enrollment203edocs@naperville203.org or they may be brought into our Centralized Enrollment Office.
