WHERE: All practices are held at Naperville Central High School
WHO: All swimmers* capable of meeting the minimum requirements
**Swimmers need not be residents of Naperville District 203*

Three sessions are available:

Session 1	Appropriate for 10 & Under swimmers	May 4-8: 6:30 - 7:15pm May 11-22: 6:00pm - 6:45pm	\$100 (14 practices)
Session 2	Appropriate for 9 & Older swimmers	May 4-8: 7:15 – 8:00pm May 11-22: 6:45pm - 7:30pm	\$100 (14 practices)
Advanced	Appropriate for 12 & Older swimmers	May 4-8: 8:00 – 9:00 pm May 11-22: 7:30pm – 8:30pm	\$130 (14 practices)

*Note: There is overlap in age ranges to accommodate differences
in swimmers' experience/ability levels*

Requirements:

Session 1: Capable of swimming 25 yards of the pool without stopping in freestyle and backstroke. Most appropriate for swimmers who are still working toward solidifying technique in all four strokes (free, back, breast, fly).

Session 2: Capable of swimming all four strokes legally without stopping for 100 yards. Most appropriate for swimmers who need refinement of technique in all four strokes.

Advanced: Capable of swimming all four strokes legally for 200 yards. Most appropriate for those swimmers who are looking for technique refinement as well as additional time in the water to improve endurance levels.
