#### **Requirements:**

**Session 1:** Capable of swimming 25 yards of the pool without stopping in freestyle and backstroke. Most appropriate for swimmers who are still working toward solidifying technique in all four strokes (free, back, breast, fly).

**Session 2:** Capable of swimming all four strokes legally without stopping for 100 yards. Most appropriate for swimmers who need refinement of technique in all four strokes.

**Advanced:** Capable of swimming all four strokes legally for 200 yards. Most appropriate for those swimmers who are looking for technique refinement as well as additional time in the water to improve endurance levels.
