What are the options as a procedural direction?

Superintendent Bridges noted that the delegate can only vote to adopt or not adopt but it will be helpful to let them know ahead of time that the plan is to appeal.

We need to let them know that we are going to appeal.

In the past the do not adopts were not voted on, the districts had to appeal. There was discussion at the beginning of the assembly and voted as to whether or not it is added back to the agenda.

Do we want to see what kind of support we have from other districts? Is that just calling around? I am willing to make some calls to fight for this resolution.

Board member Kozminski was asked to get as much information as possible and we will continue to work on it.
