

MINUTES
SPECIAL MEETING OF THE BOARD OF EDUCATION-LEGISLATIVE BREAKFAST
COMMUNITY UNIT SCHOOL DISTRICT 200
September 16, 2016

A special meeting of the Board of Education of Community Unit School District 200, DuPage County, Illinois, was called to order at Wheaton Warrenville South High School, 1920 South Wiesbrook Road, Wheaton, IL, by District 200 Superintendent Dr. Jeff Schuler, on Friday, September 16, 2016, at 7:35 AM. PLEDGE OF ALLEGIANCE

Superintendent Jeff Schuler asked everyone to stand and led the group in the Pledge of Allegiance.

INTRODUCTION OF BOARD MEMBERS, SUPERINTENDENTS AND LEGISLATIVE GUESTS

Superintendent Schuler welcomed all and introduced District 200 Board President Jim Vroman, who thanked everyone for coming and looked forward to the lively discussions that occur when the three organizations are present and share their views. Dr Schuler introduced Terry Fielden, District 203 Board President who thanked the legislators for their time and reinforced that the Districts' interest are for the students, who will guide and shape the future of our country. Superintendent Schuler introduced Mike Raczak, District 204 Board Vice President, who thanked District 200 and WWSHS for hosting and believes this event improves relationships with the other districts.

Dr. Schuler introduced his two colleagues, Superintendent Dan Bridges of Naperville District 203 and Superintendent Karen Sullivan of Indian Prairie District 204.

Superintendent Schuler asked all legislator partners to introduce themselves and the areas they represent.

DISCUSSION ITEM - LEGISLATIVE TOPICS/UPDATES

Dr. Schuler stated that the goal for the morning was to engage in legislative discussion on key issues which Districts 200, 203, and 204 have identified. He believes that together, the triad of these three districts makes one of the strongest educational centers in the State of Illinois, if not the Country.

The Superintendents introduced the three issues which their Boards of Education identified for discussion. They included:

- Illinois school funding reform commission update
 - The need for equity and adequacy to be addressed in evidence based model
 - Hold harmless agreement - discussed, but not defined
 - Money – where we will get dollars to fund new model

- Pension reform and the impact on each of the districts
 - Anticipated cost shift and what this may look like
 - Need to know it is coming and need the tools to know how to manage it
- The intricate puzzle that each of the issues form
 - Cannot deal with one of the issues in isolation
 - Compromise is necessary in order to move forward on the issues

The Legislative partners shared their thoughts and input on each of the issues. There was discussion on related topics including TRS pension system and reform, categoricals, mandates in Springfield, collective bargaining influence, managing districts at the local level, November election results, and lame duck.

They recognize that the partnership does not end after the breakfast.
