### 5.03 Mutual Interests

Superintendent Schuler highlighted Expanding Learning Opportunities (ELO) which involves the three districts working together to allow for this opportunity for their students.

### 5.04 State Legislation

Superintendent Bridges reviewed the impact that Senate Bill 16 impact would have on each District. The three Districts represented this morning would face the three largest reductions in state funding in DuPage County and in the top six statewide, if SB16 passes.

The State Representatives and State Senators expressed their thoughts regarding SB16 on school funding, as well as SB1 pertaining to pensions.

School Board members expressed concern over the fact that the State has not adequately funded education, yet continues to increase mandates.

School board members encouraged all to engage in conversation and listen to our constituencies. Additionally, it was stated to the State Representatives and Senators that this issue is about all children in the state of Illinois. We need to adequately fund education in this state.

6. Public Comment

Laura Swanson emphasized the importance of her children's education. She encouraged all to contact their local legislators to express their views. She implored the state legislators to not lose sight of what is important. It is imperative to they find an equitable and responsible solution.

Warren Dixon, Naperville Township Assessor, expressed that one point left out of the discussion is the TIF situation in the City of Chicago. Most of downtown and a significant portion of the county have large TIF districts which impact the funding component. Please include as part of conversation going forward. It is never talked about and never understood.

Thom Higgins questioned what SB16 does in terms of taking over employee pension for Chicago public schools.
