## INTRODUCTIONS & DISTRICT OVERVIEWS

Superintendent Schuler and Board President Hanlon welcomed and thanked everyone for coming to this event – a tradition that was done every year with the three districts that took a break for a couple of years. The inspiration to reengage came from a visit to the newly renovated CLC (Collaborative Learning Center) space in Johnson which came from a capital grant through Rep.

Yang Rohr's office. Johnson Elementary is District 200's most diverse elementary school and the desire was to have an open hub to the building where a lot of work and support with the students would happen.

The desire for the meeting was to have a series of collaborative dialogues. The three Superintendents and Board Presidents met to brainstorm and develop some topics for discussion.

Superintendents Bridges, Talley, and Schuler provided an overview of each of the three districts. Each legislative representative was asked to introduce themself to the group.

Superintendent Schuler noted the format for the meeting would allow the opportunity for the group to engage in two different dialogue groups to discuss the following topics:

# **Discussion Group One Topics:**

- Funding Topics (Evidence-Based Model, IDEA)
- Best Practices for Measuring School Performance
- Post-Pandemic What Have We Seen in Schools or Communities Following the Disrupted Years of the Pandemic
- Demographic Shifts in Communities and Schools and the Impact on School Services

## Discussion Group Two Topics:

- Impact of Technology on Education and Society (AI and Other Influences)
- Mental Health Supporting Needs We See in Our Communities and Schools
- Early College Options Dual Credit and Industry Credentials
- Reducing the Carbon Footprint Green Initiatives

For each of the topics, the participants were asked to consider two questions:

- What are you seeing/hearing around the topic? And share any experiences or thoughts on the topic.
- Are there next steps we should explore together to move forward and make some difference? All of the participants have a shared interest in education and the vital role that it serves in our communities.

The three districts (200, 203, 204) represent a shining hub for education in the state of IL and are doing incredible work for kids. The more we can do together to share the work with each other and outside of the space is an incredible opportunity.

The State Senators, Representatives, Superintendents, and other staff met in the different discussion groups to engage in dialogue on the various topics.
