Superintendent/ Staff/School Reports #456

A. Elmwood Elementary Students Setting Goals

Kelly Talaga, Instructional Support Coordinator at Elmwood Elementary School, began Elmwood's report on students as self-directed learners by introducing first grade teacher, Nate Bornancin, fifth grade teacher, Jamie Pignatelli, and fifth grade teacher Allison Benning. They demonstrated how the students are taking responsibility for their own learning by interviewing students from 1st grade, band, 5th grade and participants in the Study Skills Academy. First grade students set goals and tracked their progress around how much time they would spend independently reading. Band students evaluated their practice time; what went well and what they could improve on. Fifth grade students evaluated a project they had done, reflecting on the quality of their work and what they could improve on. Fifth graders also reflected weekly on their overall strengths and areas of improvement across all their areas of study. The Study Skills Academy participants graphed their progress related to reading fluency on a daily basis.

Board members complimented the teachers for their work and thanked the students for participating.

B. Enrollment Projections

Dr. Raczkiewicz explained that the demographic projections are holding true to our enrollment figures. Next year there is expected to be a 2.5% decrease in enrollment overall – mostly at the elementary level - which could potentially result in a reduction in elementary teachers.

C. Facilities Update – Prototypical Classroom

Mr. Williams noted that within the next 4-5 weeks, a general education prototypical classroom is being set up in the LRC at NCHS to try out some new movable furniture and get staff reaction.

D. E-Rate Contract

Mr. Williams reported that two E-Rate Contracts will be awarded. The first to

hire a different provider than the contractor hired last year to bring fiber to the junior high schools. This would be only in the event that the first contractor does not finish the work. The second contract would be to provide fiber to the elementary schools. The contracts will be awarded before the February 17, 2009 Business Meeting, but submitted to the Board at that meeting.

President's Report #457 Mrs. Price noted that after interviewing candidates for the Superintendent's position and Board members making a site visit, the Board will hold a Special Meeting on Monday, February 02, 2009, 7:00 p.m. to make the announcement of who the new superintendent will be beginning July 1, 2009.
