#### Good News

District 203 Schools Honored by the National Network of Partnership Schools

Naperville School District 203 is the winner of a 2009 Partnership District Award from the National Network of Partnership Schools at Johns Hopkins University. This is the District's tenth annual Partnership District Award – "evidence of its strong commitment to improving and sustaining excellent school, family, and community partnerships," noted Network founder Dr. Joyce Epstein.

District 203's *Computer Redeployment Program*, is included in the new edition of *Promising Partnership Practices* of 2009, which is published nationally. The NNPS Awards Committee praised the quality of the District's communications about partnership programs and the support you are providing to principals.

Highlands Elementary School also received its ninth annual Partnership School Award, while Prairie Elementary received its first national award. Prairie's School Family Community Partnership team was honored for its creative work on *MATHacascar* and for creating connections with the community through its International Night. Highlands was praised for continuing its family math nights and for conducting unique and important activities, such as addressing the topic of *Healthy Balance*. The promising practices of six additional District 203 schools – Beebe, Ellsworth, Kennedy, Lincoln, Naperville Central and North - are also included in the book.

#### Communications Office Wins 4 State Awards

Melea Smith noted that The Illinois Chapter of the National School Public Relations Association (INSPRA) recently presented a Golden Achievement Award of Merit to Director of Communications Melea Smith for District 203's

"Take Back the Backpack" campaign which introduced vB203, our virtual backpack webpage to the community. Earlier this summer, vB203 garnered a Golden Achievement Award from the national organization, known as NSPRA.

Smith and District 203 Webmaster Deanne Fulner also won an Award of Excellence for the recent redesign of the 21 District 203 school websites, as well as Awards of Merit for marketing materials created for the Naperville Education Foundation's "Yuks for Youth" comedy event and the 2009 "Building a Passion for Our Global Community" breakfast.

Naperville District 203 named in top 5% by SchoolSearch

Naperville District 203 has once again been recognized by SchoolSearch with a *Bright A*<sup>+</sup> *Award* for academic excellence. Of the 868 Illinois school districts, only 58 were so honored. The award criteria are based on test data taken from the 2008 Illinois School Report Card; 2009 Bright A<sup>+</sup> honorees represent the top 5% of Illinois districts, using both ISAT and ACT scores to measure student academic performance. District 203 has been honored with this award for the past 10 years. SchoolSearch is a national educational research and consulting firm based in Missouri that works with major companies by providing their relocating families with school information.

In addition, District 203 has received the *What Parents Want Award* from SchoolMatch every year since its inception in 1992. A similar organization headquartered in Ohio, SchoolMatch names a select group (the top 14%) of the nation's public schools that have been recognized for meeting the needs of families choosing schools.

Also appearing on the show, hosted by Mark Mitrovich was Assistant Superintendent for Instruction Tim Wierenga and Director of Assessment Dave Chiszar. The topic of the show is District 203's assessment philosophy and practice.

# Superintendent/ Staff/School Reports

### Superintendent Mitrovich reported:

His first article for the Daily Herald will be in the newspaper in a couple days.

Air quality and environment at NCHS are being monitored very closely. The District is taking this very seriously and trying to be proactive and anticipatory to allay any rumors and fears.

On October 19, the Mill Street School dedication will take place from 3:30 – 5:00 p.m. The community is invited to come and take a look at the new and renovated building.

On Friday, Superintendent Mitrovich has been invited for breakfast in Chicago with Arne Duncan, Secretary of Education.

Tim Wierenga reported that staff has completed the third DataSpa. Groups of school staff look at data accumulated from state and local testing and surveys. They look at the school improvement planning process and how it aligns with

the mission. Schools set their goals and how they will measure their progress. Feeder schools have worked together this year.

Challenge Day will be held at NCHS on October 26, 27, and 28. A non-profit organization, funded by Title Four dollars, will be brought in to identify and deal with social emotional needs related to bullying and other needs. With parental permission, 100 students a day determined by lottery, will take part. 20 staff members will work with the groups of students each day. The Challenge Day website is <a href="www.challengeday.org">www.challengeday.org</a> for more information about the organization.

Kitty Ryan reported that the majority of the students, except the very young ones, had an opportunity to view President Obama's speech. Schools chose to show it in different ways, some in social science classes and some in auditoriums so it was meaningful to the students. Principals have received very positive feedback and comments.

## Administrator Salary Report

Mr. Zager reported that the State enacted a statute on August 13, 2009 requiring all school districts to create a salary and compensation report for all certified staff with an administrative certificate working in that capacity. The report must be published on the District Web Site no later than October 1 each year. Additionally, the report must be presented at a regularly scheduled meeting of the Board of Education and then submitted to the Regional Office of Education. The format and content of the report was reviewed by our attorney for compliance with the statute.

#### Math Roll-Out

Mr. Wierenga reported that the District curriculum process provides for staff input in planning out the curriculum. The first two years are used to plan, research and select state and district objectives. The District assessment is designed. The curriculum is then rolled out in years 3, 4, and 5. Students set their goals, talking about which targets they understand and which they need to study and work on to learn. Years 6 and 7 are used to revise and improve the curriculum. Learning teams meet to share information about successes and struggle portions. They look at ISAT data and see how well we are meeting the learning targets. They look at best practice and determine the best teaching methods.

Superintendent Mitrovich will address a request to have access to SharePoint.

Mr. Weaver also showed pictures of the pool at NNHS. Since the pictures were taken, the pool has been filled.

Mr. Weaver showed pictures of students practicing on the new synthetic turf at NCHS. He noted that the steel in the other section of the three story addition is up and welding is going on now. Concrete pre-cast flooring will arrive next week. The footings are in place in the trainers' area and walls will be going up next week.

Mr. Fielden noted that things are going along well. He reviewed the following items:

- 1. Overtime costs for the ECC:
  - Fielden moved the reauthorization of the remaining funds in the soils remediation allocation for expenditure in schedule acceleration costs for the trades as outlined as an "order of magnitude" in the summary by Lamp Construction and approval by Ralph Weaver. Crotty seconded the motion. A roll call vote was taken. Those voting yes: Fielden, Crotty, Romberg, Jaensch, Dennison, Weeks, and Price. No: None. The motion carried.
- 2. Motion to give Ralph Weaver change order authority:

  Dennison moved that Ralph Weaver be granted authority by the Board of Education to approve change orders to the various trade contracts for the work related to the Facilities improvements at Mill Street, Naperville North High School Pool and Parking Lot Renovations, Early Childhood Center and Central High School in an individual case amount not to exceed \$100,000.00. All authorized changes will be presented to the Board Facilities Subcommittee as a discussion item for monitoring. Crotty seconded the motion. A roll call vote was taken. Those voting yes: Fielden, Crotty, Romberg, Jaensch, Dennison, Weeks, and Price. No: None. The motion carried.
- 3. Motion to give the Board Facilities Subcommittee change order authority: Crotty moved that the Board Facilities Subcommittee be granted authority to approve change orders to the various trade contracts for the work related to the Facilities improvements at Mill Street, Naperville North High School Pool and Parking Lot Renovations, Early Childhood Center and Central High School in an individual case amount not to exceed \$250,000.00. All authorized changes will be presented to the Board of Education as a discussion item for monitoring. The Subcommittee Chairman will report all expenditures to the Superintendent who will accordingly advise the Board as the nature of the change may require. Weeks seconded the motion. A roll call vote was taken. Those voting yes: Fielden, Crotty, Romberg, Jaensch, Dennison, Weeks, and Price. No: None. The motion carried.

Mrs. Romberg noted that later in the meeting the Board would vote to have a consistent starting time of 7:00 p.m. for all Board of Education meetings beginning with the October 5 meeting. She also noted that in planning future Board of Education meeting calendars, if there is school held on a Monday that is the first or third Monday of the month, the Board Meeting will be held that evening.

Mr. Jaensch addressed the \$9 million fund balance in the insurance item in the

Consent Agenda. Mr. Zager commented that the District has had favorable claims to date and that \$8 million is a good target for the size of our fund. It was suggested that since the balance will continue to go up, that a reduction in premiums might be considered.
