## PROM: Enjoy Your Event Safely and Legally from NPD

To ensure the positive and healthy celebration of prom and high school graduation, the **Naperville Police Department** reminds youth, parents and others of the following laws, which have been summarized:

**Zero Tolerance**: It is unlawful for any person under the age of twenty-one (21) to drive a vehicle after consuming *any* amount of an alcoholic beverage. Consequences include suspension of driving privileges.

**Obtaining Alcohol by Minor/Consumption:** It is unlawful for any person under the age of twenty-one (21) to purchase, sell, give or receive as a gift, or consume any alcoholic beverage.

**False Identification:** No person shall transfer, alter or deface an identification card, use the identification card of another, carry or use a false or forged identification card, or obtain an identification card by means of providing false information.

**Possession of Alcohol by Minors:** It is unlawful for any person under the age of twenty-one (21) to possess any alcoholic beverage, or to be present or remain in any room, apartment, house, place, or vehicle where alcoholic liquor is being consumed by persons under the age of twenty-one (21).

## PARENTAL RESPONSIBILITIES

- No parent or other person shall intentionally, knowingly, recklessly or negligently give or deliver alcoholic liquor to, or permit possession of alcoholic liquor by, his or her child, or any other person under the age of twenty-one (21).
- No parent or other person shall intentionally, knowingly, recklessly or negligently give, deliver, invite or permit the consumption of alcoholic liquor by any person of non-age on or about any premises owned, leased, or controlled by such parent or person.

**Hotel and Motel Rooms:** No parent or other person shall rent, or otherwise permit the use of any hotel or motel sleeping rooms or suites, when such person knows, or in the exercise of ordinary care should know of a substantial probability that such space will be used by underage persons for the consumption or possession, either actual or constructive, of alcoholic liquor.

This information is provided as a public service to facilitate discussion regarding the detrimental effects and consequences of underage possession and consumption of alcoholic beverages, including accidents, illness and arrest. ## DANCE ATTIRE GUIDELINES

If a student or their approved guest chooses to wear a dress: Spaghetti straps, strapless gowns, and 2 piece dresses are allowed, as long as they are not low cut and below the bust line. The cut of a dress in the back and sides must not be cut below the naval. Two piece dresses are allowed if the space between the top and skirt is two inches or less. The top must not show any cleavage or have cut outs. SHEER MATERIAL may need to be used to cover exposed areas. A dress, skirt or gown must be longer than mid-thigh. Dress length trends vary from dance to dance. Prom is typically a long dress or gown style.

If a student or their approved guest chooses to wear a tuxedo or suit: A shirt is expected to be worn under the tuxedo or suit upon arrival and at all times during the dance. Jeans/shorts are not permitted at formal dances.
